2. Parts, appliances or services furnished by any suppliers located in a foreign country may not be used in the production of any product unless:
 - a. that part or services can and will be completely inspected for conformity to the approved design data at the authorised manufacturer's Australian facility; and
 - b. CASA has determined that the supplier's location places no undue burden upon CASA in administering the applicable airworthiness requirements; or
 - c. the parts or services furnished by the foreign supplier are produced and approved for import to Australia in accordance with regulation 21.502 of CASR.
3. Under this certificate you cannot:
 - a. Manufacture products using "Additive Manufacturing" (3D Printing).

Note 2: This Production Certificate ceases to be in force in accordance with paragraph 21.159 (1) (a) of CASR if the location of the manufacturing facility changes.
